Sub. No. 1 GRADUATION EXERCISE - TRAINEE CONSTABLES

A passing-out parade, certificates and awards ceremony will be held for two hundred and seventy seven trainee Constables at the National Police College of Jamaica, Twickenham Park, St. Catherine on *Friday*, *June 9*, 2023 commencing 10:00 am.

The parade will be held in the presence of the Honourable Dr. Horace Chang, MP, Deputy Prime Minister of Jamaica and Minister of National Security. The Honourable Dr. Horace Chang will be the Reviewing Officer. He will inspect the parade and take the General Salute.

Officers, Inspectors and other ranks of the Jamaica Constabulary Force and Rural Police are invited to attend.

All persons attending should be seated by 9:30 am.

Sub. No. 2 REMINDER - CANCELLATION OF ADMINISTRATIVE DIRECTIVES RELATING TO THE CORONA VIRUS ENDEMIC

Force Orders No. 3964, Part I, Sub. No. 1 dated 2023-05-25, is hereby republished for general information.

Consequent on the directive of the Government of Jamaica, the Corona Virus Endemic is to be treated within the normal management of public health, public safety and public order.

Effective from the date of these Orders, Administrative Directives dated March 13 & 27, 2020, June 19, 2020 and March 15, 2021 treating with vacation and departmental leave, temporary transfers and work from home, are hereby **cancelled**.

The granting of leave and other matters captured in the directives will be treated in accordance with the relevant Force Orders, Rules and Regulations.

Commanding Officers are to ensure that all previous arrangements are reviewed and adjusted to comply with pre COVID-19 Rules and Regulations.

Sub. No. 3 REMINDER - HURRICANE STANDING ORDERS - JAMAICA CONSTABULARY FORCE

Force Orders No. 3936, Part I, Sub. No. 4 dated 2022-11-10, is hereby republished for general information.

We are now in the hurricane season for 2023 and it is imperative that all ranks be reminded of the actions to be taken in the event that a hurricane affects Jamaica, during the hurricane, or after the passage of the hurricane.

An immediate audit must be conducted on the number of lanterns available at each police station and where there is an inadequate number; representation must be made to the Assistant Commissioner of Police in-charge Services Branch for additional supplies.

HURRICANE STANDING ORDERS

- 1. The purpose of these Orders is to ensure that:-
 - (a) hurricane warnings are disseminated to all police formations;
 - (b) all practicable precautions are taken in advance to minimize the risk of injury to personnel and the loss or damage to equipment and buildings during a hurricane; and
 - (c) the police take action immediately after a hurricane to make a rapid survey of damage and report to Headquarters, affording possible assistance to those in distress as well as the Municipal Corporations and the Office of Disaster Preparedness and Emergency Management.

<u>REMINDER - HURRICANE STANDING ORDERS - JAMAICA CONSTABULARY FORCE</u> (CONT'D)

WARNING PROCEDURE

- 2. Information regarding the progress of hurricanes in the Caribbean is supplied by the Meteorological Office to this Headquarters.
- 3. When a hurricane is likely to affect Jamaica, warnings will be phased as follows:-
 - PHASE 1 When a notification is received that a hurricane which is likely to affect Jamaica is in the Caribbean. (Hurricane Alert).
 - PHASE 2 When notification is received that a hurricane is likely to strike Jamaica within 24 hours. (This is the Departmental 24 hours warning).
 - PHASE 3 When notification is received that a hurricane is likely to strike Jamaica within 12 hours. (This is the Departmental 12 hours warning).
 - PHASE 4 When notification is issued that a hurricane is likely to strike Jamaica in 6 hours or less.
- 4. In addition to the above, warnings will be issued through the communications medianewspapers, radios and television. A red flag with a black square will be hoisted at Post and Telegraph Stations to indicate that a hurricane warning has been received. Particulars of the warning will be on the notice board at the stations.

The Harbour Master will cause the following signals to be displayed in Kingston from the flagstaff at his Headquarters, New Port East-

BY DAY

Two red flags with black center squares
BY NIGHT

Two red lights vertically placed six feet apart.

It is appreciated that some rural stations may not receive PHASE4 warning in time and therefore sub-officers in-charge stations should listen to the radio stations after the PHASE 3 warning has been issued.

EMERGENCY CONTROL ROOM

- 5. At PHASE 2, a National Control Room will be set up at 103 Old Hope Road (Office of the Commissioner of Police) with JDF representatives and necessary equipment.
- 6. The police will be represented by the Assistant Commissioner of Police in-charge Operations Branch and Superintendent of Police in-charge Telecommunications Division. The latter will provide emergency lighting and auxiliary power supply for all equipment necessary. He will also provide wireless communications on the JCF Network.

ACTION ON RECEIPT OF WARNING:-

- 7. The Officer at Police Emergency Communications Centre (PECC) on receipt of a hurricane warning from the Meteorological Office will inform the persons attached to these Orders as <u>Appendix 'A'</u> by the quickest means available:-
- 8. Messages should be brief and should contain a summary of the latest weather report, preceded by the phase "Hurricane Warning Phase one, two, etc."
- 9. Officers in-charge Areas, Divisions/Formations, Stations and Branches will ensure that warnings are passed to all personnel under their command and occupants of Government Quarters.

RELAXING PRECAUTIONS:-

10. Hurricane Phase will NOT be cancelled or precautions relaxed except on authority from Police Headquarters.

PRECAUTIONS BEFORE AND AFTER A HURRICANE:-

- 11. Attached as to these Orders as <u>Appendix 'B'</u> is the general precautions to be taken before and after a hurricane. This list will be valuable not only to the Police, but to members of the public who seek advice and information at Police Stations.
- 12. Attached to these Orders as <u>Appendix 'C'</u> gives the preparations which are to be made by the Police in regards to their stations and duties.

CHARACTERISTICS OF A HURRICANE:-

13. The general characteristics of hurricanes are given at Appendix 'D' to these Orders.

ACTION DURING HURRICANE

- 14. All fires in cooking stoves will be extinguished.
- 15. All ranks will remain safely indoors or suitable cover.
- 16. Wireless communications will be maintained if possible with all stations. When radio equipment is threatened, the set will be secured and outside equipment taken down and stored. Before this is done, PECC should be informed of the closing down of the Station.
- 17. Wireless contact shall be established as soon as possible. The Superintendent in-charge Telecommunications Division will direct immediate action to repair any damaged wireless equipment, and will treat the re-establishment of communications with the highest priority.
- 18. Immediately the weather abates, police should be dispatched in several directions throughout the districts to make a rapid survey of damage done to property, buildings, cultivations and communications.
- 19. Divisional Officers will forward an appreciation of the situation to Police Emergency Control Centre and Area Headquarters with as little delay as possible and by the fastest means available.

ACTION AFTER HURRICANE

- 20. In any event, Area Officers will forward to PECC, daily reports by 1:00pm and, additionally, each day as the situation warrants and/or as directed by the Commissioner of Police.
- 21. As soon as the necessary information is collected, a full report (in duplicate) of all damage, under the following headings, will be forwarded to Police Headquarters by Divisional Officers through Area Officers:-
 - (a) persons killed or injured;
 - (b) persons in distress and homeless, and where housed for shelter;
 - (c) general condition of inhabitants with regard to food, clothing, shelter, etc.;
 - (d) damage to crops, houses, factories and government property;
 - (e) animals or livestock killed or injured;
 - (f) damage to communications, that is, roads, telegraph, telephone and wireless systems and
 - (g) damage to vessels, boats, etc.

- 22. The police will co-operate fully with the ODPEM, the local Emergency Relief Committees, the Central Emergency Relief Committee, the St. John Ambulance Brigade and the Jamaica Red Cross Society.
- 23. There may be hunger and destitution and the police will render every possible assistance. The police may be called upon to perform duties which are not provided for in these Orders, and all ranks must be prepared to do everything necessary to restore normalcy. It must be clearly understood, however, that this instruction does not include authority to incur expenditure which cannot be subsequently justified.

MOBILE RELIEF COLUMNS

24. These will be provided as directed by the Commissioner of Police and each detail will be commanded by an Inspector, at least.

Assistant Commissioner of Police, Specialized Operations, will therefore maintain a Special Store of suitable food, water and first aid items for this purpose.

The purpose of the Mobile Relief Column will be to render assistance after the hurricane to persons, especially children, marooned and suffering in otherwise inaccessible areas.

ASSISTANCE TO MET OFFICE

25. When members of the staff are unable to contact their office at the Norman Manley International or Donald Sangster International Airports after a hurricane, they will report to the Highway and Safety Patrol Division, Elletson Road or the Freeport Police Station in Montego Bay for assistance.

The Police Officer concerned will contact the National Works Agency to provide transport and will render any other assistance possible.

If telephone communication is impossible or non-existent when the MET Office wishes to pass a hurricane bulletin to Police Headquarters, etc., such bulletin will be passed in writing to the police station at the Norman Manley International Airport.

The police there will pass the information to PECC by the fastest means available. The Officer at PECC will then notify the following as to its contents – Radio Stations, Telephone Companies and Central Emergency Relief Committee.

All members will ensure that they are aware of the provisions of the Hurricane Standing Orders.

Area, Branch and Divisional Commanders will ensure that all ranks are lectured on the requirements of these Orders, and will forthwith make suitable arrangements for the protection of Force vehicles (including police launches), buildings and other items of Government Property under their control in the event of a hurricane.

APPENDIX 'B' HURRICANE PRECAUTIONS (GENERAL) TO FORCE ORDERS NO. 3965 DATED 2023-06-01

HURRICANE PRECAUTIONS (GENERAL)

Before the Hurricane

The following safety measures will be helpful as a guide to the action to be taken when warnings are issued of an approaching hurricane.

- Keep your radio on and listen for latest warnings and advisories.
- Pay no attention to rumours. Rely on the official Weather Bureau advices and warnings.
- Get away and stay away from low-lying beaches or other locations which
 may be swept by high tides or storm waves. If your only passage to high
 ground is over a road likely to be under water during a severe storm, then
 leave early.
- If your house is out of the danger of high tides and is well built (securely anchored to foundation with a good roof also securely fastened) then it is probably the best place to weather out the storm.
- Board up windows or put storm shutters in place. When you board up, use good lumber securely fastened. Makeshift boarding may do more damage than none at all. Have strong bracing for outside doors.
- Get extra food, especially things which can be eaten without cooking or with very little preparation. Remember that electric power may be off and you may be without refrigeration.
- Emergency cooking facilities (oil and coal stoves) may be necessary; be sure they are in working order. Procure a supply of kerosene oil and charcoal.
- Sterilize the bathtub and fill it with water. Also sterilize and fill all jugs, bottles, cooking utensils and containers, as the water supply may be interrupted. Even for some time after service has been restored, it is advisable to boil drinking water, unless you are sure the supply received from water mains is safe.
- Have a flashlight in working condition and keep it handy, also candles and storm lanterns.
- 10. Check on everything that might blow away or be torn loose. Garbage cans, garden tools, signs, porch furniture, awnings and other objects become weapons of destruction in hurricane winds. Store them all inside if possible. Loose objects on the roofs of buildings are especially dangerous.
- Heavy foliage of fruit and economic trees near buildings should be lightened. If the force of the winds is likely to be over 50 miles an hour, all nuts should be also removed from coconut trees near buildings.
- Be sure that a window or door can be opened on the leeward side of the house (the side opposite the one facing the wind).
- 13. If the centre or 'eye' of the storm passes directly over, there will be a lull in the wind lasting from a few minutes to half an hour or more. Stay in a safe place, unless emergency repairs are absolutely necessary, but remember the wind may return suddenly from the opposite direction, frequently with even greater velocity.

After the Hurricane

After passage of the hurricane, the following safety rules will prove valuable:-

- (a) Seek medical aid at First Aid Stations, Hospitals, Clinics or Health Centres for person injured during the storm.
- (b) Do not touch loose or dangling electric wires. Report such damage to the light and Power Company, or the nearest police officer.
- (c) Report broken sewer or water mains to the Parish Council or National Works Agency.
- (d) Do not empty water stored in bathtubs or other receptacles until you are sure that a safe water supply has been restored.
- (e) Guard against spoiled food in refrigeration if power has been off for any length of time.
- (f) Take down shutters and save the lumber. Store in a handy place for future use.
- (g) Beware of broken tree limbs. Collect fallen limbs and debris around the premises and pile along curb to facilitate collection.
- (h) Unless you are qualified to render valuable emergency assistance, stay away from disaster areas where you may hamper first aid or rescue work.
- (h) Drive automobiles cautiously. Debris filled streets are dangerous so keep your eyes on the road. Along the coast, the soil may collapse under the weight of vehicles.
- Be alert to prevent fires. Lowered water pressure makes firefighting difficult after storms.

APPENDIX 'C' HURRICANE PRECAUTIONS (POLICE) TO FORCE ORDERS NO. 3965 DATED 2023-06-01

HURRICANE PRECAUTION (POLICE)

The following preparations will be made at all police stations, offices and quarters:-

Before the Hurricane

Radio

Superintendent of Police, Telecommunications Division will send equipped radio cars to Port Antonio and Morant Bay. Other radio equipped vehicles will be placed on duty at the following points:-

Police Headquarters, 103 Old Hope Road, Kingston 6
Half Way Tree Police Station
Hunts Bay Police Station
Cross Roads Police Station
Denham Town Police Station
National Police College of Jamaica
Harman Barracks
Constant Spring Police Station
Norman Manley International Airport Police Station

Spare batteries will be supplied to the radio equipped vehicles posted away from the Corporate Area.

The Commissioner of Police will be in constant radio communication by means of the radio equipment in his car.

Spare batteries must be made available to the Commissioner of Police and the Deputy Commissioner of Police, Operations for radios in their cars.

The Superintendent of Police, Telecommunications Division, will ensure that Kingston Central and Police Control Centre are lit by the auxiliary Lighting Plant.

Lighting

At all Stations every serviceable lamp as well as boxes of matches should be kept in the Station Office. Flashlights should be available for use. Officers should provide their own flashlights.

Protection of Buildings

Doors and windows at Stations should be locked or made secure. If nails and bits of board are required, funds should be made available from moneys under the control of Divisional Officers. At each Station, a Sub-Officer should be detailed to ensure that doors and windows are securely fastened. The local office of the National Works Agency is to be requested to give as much assistance as possible. All government properties are to be safely stored away.

Emergency Food Supply

Stations with Canteens should get in stocks of essential food stuff such as flour, tea. Condensed milk, boxes of crackers and cornmeal, as well as other inexpensive food.

Water Supply

All available vessels at Stations should be filled with water and kept under control. All empty bottles should also be filled for drinking purposes.

Personnel

APPENDIX 'C' (CONT'D) TO FORCE ORDERS NO. 3965 DATED 2023-06-01

When information is received that the hurricane will hit Jamaica, where possible, all married personnel who live with their families in the Station Area, and in respect of Kingston and St. Andrew Station, all those who live with their families in the Corporate Area should be allowed to go home. All personnel should be withdrawn from the streets. At Half Way Tree, Constant Spring, Cross Roads, Hunts Bay, Deaham Town and Elletson Road Police Stations: Control and all Head Stations in the country divisions, there must be senior sub-officer in Barracks.

Married men should be return to their stations as soon as the hurricane has abated and it is safe for them to leave their homes.

Vehicles

Officers will arrange for safe parking of their vehicles.

Motor cycles

Motor cycles should be distributed at strategic points in divisions for the conveyance of information after the hurricane.

First Aid Boxes

All First Aid Boxes should be checked and deficiencies made good.

After the Hurricane

Looting

Officers will consider the advisability of making arrangements in advance for the patrolling of streets and the protection of shops and other property.

APPENDIX 'D' CHARACTERISTICS OF WEST INDIAN HURRICANES TO FORCE ORDERS NO. 3965 DATED 2023-06-01

CHARACTERISTICS OF WEST INDIAN HURRICANES

In the West Indies the season begins in June and ends in November.

It is impossible to lay down rules about hurricanes.

The average daily movement of a tropical hurricane has been found to be about 200 miles. Although the centre may be moving at 12 to 15 miles per hour, the wind velocities produced may be in excess of 100 miles per hour.

West Indies Hurricanes tend to travel on a <u>west north west</u> track and may recurve to north east.

The destructive area of a storm may extend to a width of from 100 to 500 miles.

A full hurricane may last from 12 to 36 hours. A hurricane may be accompanied by heavy rain, and experience has shown that it is impossible to keep it out of any building and that extraordinary precautions are required to keep essential articles dry. Some hurricanes are followed by very heavy rains for two or three days.

There often a lull of about 30 minutes during a hurricane, which is accompanied by a clearing of the sky and other appearances that the hurricane is over. Such a lull is the most dangerous factor in the hurricane, because without warning, the hurricane may recommence from a new direction at full force. Relaxation of precautions during such a lull may lead to serious results.

The dangers to be expected are:-

- flying debris
- the loss of equipment, etc., insufficiently secured
- · damage to stores by flooding
- damage to communications
- floods
- heavy seas.

No-Pay Leave is a period of approved absence from duty for which the employee does not receive a salary.

DID YOU KNOW?

That No-Pay Leave is not automatic?

HOW NO-PAY LEAVE IS GRANTED?

No-Pay Leave is granted under the following:



- ⇒ Permanent Secretaries and Heads of Departments may grant no-pay leave up to a maximum of one hundred and eighty (180) days in any one calendar year to employees on the ground of urgent private affairs.
- ⇒ Urgent private affairs relate to death in the family, illness in the family and business of such a nature which, in the discretion of the Permanent Secretary or Head of Department, necessitates the officers absence from duty.
- ⇒ All requests for no-pay leave should, be supported by documentary evidence and should, in the case of urgent private affairs, be submitted in time for the matter to be examined and approval granted before the officer proceeds on leave.
- ⇒ Where an officer applies for no-pay leave beyond one hundred and eighty (180) days, while on leave, the respective Permanent Secretary or Head of Department should examine the application and submit it only if it is supported. In cases where the leave is not approved the Permanent Secretary/Head of Department should request the officer to resume duties within a specified time, failing which the employee will be considered to be absent without permission and subject to dismissal.
